FOR TWO-YEAR-OLDS No nomination fee. \$750 to enter and an additional \$750 to start. Supplementary nominations may be made at time of entry on Wednesday, August 30, 2017 by payment of \$7,500 each (includes all fees). \$150,000 Guaranteed plus \$200,000 KTDF for KTDF eligibles only. After payment of 1% to all owners of horses finishing 6th through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. KTDF funds correspondingly divided providing a KTDF eligible horse finishes in an award position. Weight 122 lbs. Non-winners of a sweepstakes allowed 2 lbs.; a race other than claiming, 4 lbs. The maximum number of starters will be limited to twelve with four also-eligibles. In the event that more than twelve entries pass the entry box the starters will be determined at that time with preference given to the highest career earnings. At the discretion of the Racing Secretary, the also-eligibles may remain on the program and be scratched up to fifteen minutes prior to pari-mutuel windows opening. Any horse excluded from running because of the aforementioned preference shall be refunded the entry fee and supplementary nomination fee if applicable. Starters and riders must be named through the entry box by the usual time of closing. (Pari-mutuel wagering on historic horse races generated \$301,000 of the total purse).
